Owner comments

 Italia- We are working through issues with the union. We have our response to all of the issues.
 We fixed all the things the NLRB has said. (Italia went over the respect policy.) There are still quite a few policies we have to bargain over. Sharif (HR Manager) left last Friday. Alexis and Chuck will be helping.

November operations

- Troy: How is HR working? Is delegation working?
 Italia-There is no HR manager, no Produce manager, a new board/admin assistant. I am swamped right now. Delegating is difficult when the store is so short staffed. Everyone is working to help out.
